- Travel: Domestic & International, parking at clients
- Uniform: Protective clothing, dry cleaning/laundry
- Self-education – study detail & costs
- Other: Mobile phone, home phone, books, computer, internet, subscriptions, tools/equipment, home office (electricity), stationery/printing, home phone, seminars/courses, union fees, etc
- Receipts of gifts/donations to charities
- Tax & financial planning advice fees
